Greg's Perspective

1) From a scientific perspective, if homosexual activity is a natural genetic trait (and exclusive) it would either extinguish itself genetically (no procreation) or remain a genetic trace anomaly.

Biblically speaking, sinfulness and rebellion are the natural state of mankind

2) What is "being gay"? Is it determined by blood test? DNA? Lab results? or Self Declaration? Re-defining the word "marriage" violates civil contracts and treads upon an establishment of religion (violation of 1st Amendment) <http://1828.mshaffer.com/d/word/marriage> . Websters 1828 Dictionary clearly defines "marriage".... and modifications, no matter how well intentioned, can bring unintended consequences. What other words may be redefined? What other "establishments of religion" may be redefined by government? What contracts hinge upon marital status and may be substantially impacted by redefinition of the term "marriage"?

3) If there is a change to the definition of marriage for one segment of society, based upon a contrived right, others may rightly lay claim to a similar benefit of secular recognition of their preferred unions. Bestiality, pedophilia and bigamy are all widespread sexual proclivities which yearn to be accepted.

4) The word "straight" is added in order to insinuate a variety of optional marriage types. Yes, over the years new "types" of marriage have emerged: politically expedient marriages, temporary/short-term marriages, open marriages, friends with benefits marriages and all about business marriages. NONE of these change the definition of marriage and none of these are right.

5) Degradation, brought about by societal chaos and miscreant personalities, is not a legitimate reason to dismantle the institution of marriage. (see #4, second half)

6) Again, see #4 (the word "straight") & #2. The logical question spawned by the exercise in ridiculousness is "should homosexuals be able to seek insurance-covered (contract affected by redefinition of marriage) infertility treatment, when they are biologically complete and in NO need of medical attention?" (this group has now inappropriately likened themselves to racial minorities, the elderly and those in need of medical attention)

born homosexual or can they be nurtured (or recruited) into such a lifestyle. In a depraved world, both can result in a consequential lifestyle of homosexuality. Children often mimic the activities of their caretakers and embrace those activities as their own "societal norms". Good, bad or indifferent.... these facts are evident worldwide.

8) The assault on Christianity is apparent here.

Perhaps the author should compare their feigned "American Theocracy" with much of the muslim world. A huge swath of the muslim world does operate in a totalitarian, sharia-law, context. They slaughter homosexuals and subject their citizens to horrid treatment at the behest of radical mullahs.

9) Contrary to modern teaching, men and women are different. To say otherwise would be sexist or completely ignorant of biology, anatomy, psychology and physiology.

Children raised by a married, loving, caring, involved, educated and stable mother and father have a greater chance at living happy, healthy and fulfilled lives.

10) "Gay Marriage" is not the issue.

The current societal debate is in the context of a twist on the definition of marriage. The reality is that marriage "equality" is a pretext to a larger societal question. Shall Christians be subjected to hate-crimes legislation/penalties for properly identifying a sinful activity? Often, Christians approach sin as a Biblical Pharisee. The reality is that Christians and sin are not mutually exclusive agents. Yet, as believers, we cannot rightly engage in, or endorse, sinful activities.

Beyond that, (in the United States) civil authority should not redefine a word, thus affecting private contracts, in violation of Article I Sect 10 and violating the 1st Amendment admonition "Congress shall make no law respecting an establishment of religion".

From a strict civil-libertarian perspective, these purported "marriage" issues could be overcome through contractual agreements.

The issue of "marriage equality" is subterfuge, with the intent of a direct assault upon freedom of religion.






A Nation On Trial




